§ 25-1. Statutory authority.

Pursuant to § 66.0113, Wis. Stats., the citation method of enforcement of ordinances is hereby adopted and authorized for use within the Village of Spring Green. The enforcement of an alleged violation for which a citation is issued shall be in accordance with the provisions of § 66.0113, Wis. Stats.

§ 25-2. Form of citation. ¹

The form of the citation shall be determined by the Chief of Police of the Village of Spring Green and shall provide for the information required in § 66.0113(1)(b), Wis. Stats.

§ 25-3. Schedule of cash deposits. ²

The schedule of cash deposits, on file in the office of the Village Clerk-Treasurer, which deposits include the costs, fees and surcharges imposed under Ch. 814, Wis. Stats., and, in addition, the penalty surcharge provided under § 757.05, Wis. Stats., is established for use with citations under this chapter. Any change in the costs, fees and surcharges imposed under Ch. 814, Wis. Stats., or the penalty surcharge under § 757.05, Wis. Stats., shall automatically be incorporated into the schedule of cash deposits and said deposit shall be adjusted accordingly.

§ 25-4. Receipt of deposits.

Deposits shall be made in cash or by check at the Spring Green Police Department. The officer accepting deposits shall issue a receipt for all deposits received. The amounts of the deposits shall be in accordance with the schedule established above. Deposits shall be delivered to the Sauk County Clerk of Circuit Court within 20 days after receipt.

§ 25-5. Issuance of citations.

Any police officer of the Village of Spring Green may issue citations for enforcement of any ordinance authorized herein.

§ 25-6. Citations for certain liquor ordinance violations.

- A. Authority. Pursuant to § 778.25, Wis. Stats., the citation procedures established by said § 778.25 may be used in an action to recover a forfeiture under Chapter 235, Intoxicating Liquor and Fermented Malt Beverages, of the Code of the Village of Spring Green adopting and strictly conforming to §§ 125.07(4)(a) or (b), 125.085(3)(b) or 125.09(2), Wis. Stats. The enforcement of an alleged violation for which a citation is issued shall be in accordance with the provisions of § 778.25, Wis. Stats.
- B. Citations. The form of the citation shall be determined by the Chief of Police of the Village of Spring Green and shall provide for the information required in § 778.25(2), Wis. Stats.³
- C. Issuance and signing of citations. Any police officer of the Village of Spring Green may issue citations for enforcement of the ordinance provisions specified in Subsection A of this section. A citation issued hereunder shall be signed by such police officer having authority to make arrests for the violation.⁴
- D. Deposits. The basic amount of the deposit for a citation issued under this section shall be as from time to time determined by the Judicial Conference, plus costs, fees and surcharges imposed under Ch. 814, Wis. Stats., and, in addition, the penalty surcharge provided under § 757.05, Wis. Stats. The person issued a citation under this section may deposit the amount of money the issuing police officer directs by mailing or delivering the deposit and a copy of the citation to the Sauk County Clerk of Circuit Court or the headquarters of the Spring Green Police Department prior to the court appearance date.⁵
- E. Adoption of statutory procedures. The provisions of § 778.25(5), (7), (8), (9) and (10), Wis. Stats., are hereby adopted and incorporated into this section by reference.
