### Chapter 100

### OFFICERS AND EMPLOYEES

# § 100-1. Certain elected offices abolished.

Pursuant to §§ 61.195, 61.197 and 66.0101, Wis., Stats., the offices of Village Clerk, Village Treasurer, Village Assessor, Village Constable, and Village Marshal are hereby abolished as elected offices.

#### § 100-2. Clerk-Treasurer.

The offices of Village Clerk and Village Treasurer shall be consolidated into one office and designated as "Village Clerk-Treasurer." The person filling this office shall be appointed by a majority vote of the Village Board, and this person shall hold office for an indefinite term, subject to removal as provided by law for officers appointed by the Village Board.

### § 100-3. Assessor.

- A. There is hereby created the office of the Village Assessor, who shall be appointed by the President of the Village, subject to confirmation by the affirmative vote of 2/3 of the members of the Village Board. Said Assessor shall hold office for an indefinite term, subject to removal as provided by law. Such term shall begin on May 1 of the year in which the appointment is made.
- B. The office of Assessor shall have the duties of Assessor as prescribed by the Wisconsin Statutes and subject to such other rules and regulations as shall be prescribed by the Village Board.
- C. Whenever the Assessor, in the performance of the Assessor's duties, requests or obtains income and expense information pursuant to § 70.47(7)(af), Wis. Stats., or any successor statute thereto, then such income and expense information that is provided to the Assessor shall be held by the Assessor on a confidential basis, except, however, that the information may be revealed to and used by persons in the discharge of duties imposed by law; in the discharge of duties imposed by office (including but not limited to use by the Assessor in performance of official duties of the Assessor's office and use by the Board of Review in performance of its official duties); or pursuant to order of a court. Income and expense

information provided to the Assessor under 70.47(7)(af), Wis. Stats., unless a court determines that it is inaccurate, is, per 70.47(7)(af), Wis. Stats., not subject to the right of inspection and copying under 19.35(1), Wis. Stats. 1

## § 100-4. Chief of Police.

There is hereby created the office of Village Chief of Police, who shall be appointed by a majority of the members elect of the Village Board. Said Chief of Police shall hold office for an indefinite term, subject to removal as provided by law. The compensation therefor shall be set by the Village Board. Such Chief of Police shall have the powers, privileges and duties of Village Marshals and Village Constables under §§ 61.28 and 61.29, Wis. Stats., and shall perform such other duties as may be required from time to time by the Village Board.

#### §100-5. Administrator.

There is hereby created the office of Village Administrator who shall be appointed by a majority of the members elect of the Village Board. The Administrator shall hold office at the pleasure of the Village Board for an indefinite term. The Village Administrator shall perform such duties as may from time to time be required by the Village Board. The compensation of the Village Administrator shall be set by the Village Board.
