Research Dogs/Cats. (a) Any place or premises where cats or dogs are processed for the purpose of taking or sending the cat or dog outside the village to be used for any research or experimentation OR (b) any place or premises where cats or dogs are used for the purpose of research or experimentation involving more than momentary or slight pain or distress to the animal. Nothing in this section shall be interpreted to limit the ability of residents to enroll pet dogs/cats in clinical trials that may provide benefit to the animal.
