- b. Demers stated the Park & Recreation Committee met and discussed the direction of the potential repair/replacement of the tennis courts. Demers noted if the tennis courts are repaired, the basketball courts should be repaired as well. Demers stated a rough estimate of these projects would be approximately \$60K. Demers stated

- the committee discussed fundraising ideas; hopefully other organizations can get involved as well. Demers stated the board should wait until this fall when the Lions Club makes the decision on the \$10K donation and go from there. No action taken.
- c. Demers stated the Park & Recreation Committee discussed employee wages at the pool and noted Spring Green is on the bottom of the totem pole as far as pay scale. Demers stated ideas such as pay increases, training reimbursement and "perks" were discussed. No action taken.
- d. Demers stated there will be no Summer Recreation Program this year, and interest has been declining over the last several years. No action taken.
