6. **Old Business:**

a. Hausner stated he is expecting another proposal regarding borrowing/financing TIF #6 Projects, but has not received the proposal to date. Hausner noted this item will be on the June 28, 2017 Village Board Agenda. No action taken.

- c. Reid moved and Miller seconded to approve Resolution R-1709: Preliminary Resolution Declaring Intent to Exercise Special Assessment Powers Under Section 66.0701 Wisconsin Statutes as presented. Motion carried.
- a. Michaels stated his interest in a food truck ordinance as he was thinking of a mobile pizza oven. Marcus explained when the popcorn wagon vendors withdrew from Spring Green, the issue was placed on the back burner. Marcus asked what Michaels' timeline would be. Michaels stated most likely within a month or two. Marcus stated he has looked at food truck ordinances from other larger municipalities and the requirements are very stringent along the lines of a certified kitchen, waste disposal and other items. Michaels stated he was more interested in a grill area just behind Arcadia Books. No action taken.
- b. Michaels requested permission to utilize a Village parking space adjacent to the back of Arcadia Books for grilling/preparing pizza. Miller and Demers stated they did not have any issues with the request. Marcus discussed recent issues with the coffee roasting business on Washington Street. Marcus suggested placing the request on the next Village Board Agenda due to these issues as it would give residents ample time to become aware of the request and voice any opinions. Michaels asked if he could utilize

the space during Art Fair weekend. The board was hesitant to approve the request due to timing issues. The consensus of the board was once Michaels establishes the pizza oven at the Arcadia Books location, there would be no need to request permission to offer pizza during future Art Fair weekends. This item will be placed back on the June 28, 2017 Board Agenda. No action taken.

- d. Miller moved and Reid seconded to appoint Jane Hauser to the Plan Commission, term to expire 2019. Motion carried.
- e. Reid moved and Miller seconded to appoint Kolby Hirth to the Joint Extraterritorial Zoning Committee, term to expire 2018. Motion carried.
