- 1. **Call to order:** Gene Hausner, Village President called the meeting to order at 7:16 p.m.
- 2. **Roll call of Village Board members:** Members present were Gene Hausner, Robin Reid, Joel Marcus, Norm Miller, Grace Timmerman, and Vern Demers. Michael Broh was absent. Also present were Wendy Crary, Greg Jewell, Linda Schwanke, and Sheryl McCarville.
- 3. **Approve Minutes:** Demers moved and Miller seconded to approve the minutes of the July 26, 2017 Regular Board Meeting as presented. Motion carried.
- 4. **Review and approve agenda:** Hausner requested that item 6e be moved ahead of 6d. Demers moved and Timmerman seconded to approve the agenda with the change requested. Motion carried.
