- Call to order and attendance. Todd Miller called the meeting to order at 5:31 p.m.

- 2. **Approve Agenda**. Motion by Churchill, second by Feiner to approve the agenda. Motion carried.
- 3. Motion by Feiner, second by Kardatzke to approve the minutes from the October 24, 2018 Spring Green Board of Zoning Appeals Hearing and Meeting. Motion carried.
- 4. Discussion and possible action on the consideration of a request by Joel & Stacy Pare for a variance for side yard placement of an accessory storage building on parcel #182-0130, 462 W. Monroe Street, Spring Green, WI. Miller inquired about drainage related to the new building and if any paving would occur from the street to the proposed building. Mertens pointed out that he felt that would be the reviewed during the building inspection process. Greenwood was unsure if paving would occur.
