

**Minutes of Regular Session**

Hauser requested more information about invoices from Boardman & Clark and K& L BOBCAT INC. Crary stated that the attorney fees were being addressed by Chief Stoddard and that the Bobcat was the cost of the trade-in. Motion by Hauser to approve consent agenda line item: 5.b.

6. **Old Business:**

- a. While Todd Deibert of Jewell Associates Engineers Inc. was giving an update regarding easements for the Woodbury Sanitary Sewer Project, connection was lost. Discussion was tabled to give Deibert a chance to reconnect.

7. **New Business:**

- a. Discussion on the request from John Finn to close E Adams St on July 17, 2021 from 1:00 pm to 10:00 pm, addressed noise and approval from neighbors. Finn stated that there would be music but not live and the neighbors were supportive. Questions about barricades were suggested for safety. Motion by Broh to approve the request from John Finn to close E Adams St on July 17, 2021 from 1:00 pm to 10:00 pm as requested. Seconded by Snow. Voice vote. Motion carried. Village Board asked Reno, Public Works Director, to make sure that barricades are put up. Miller added that it would be nice to see more of these parties.

6. **Old Business:**

- a. Todd Deibert of Jewell Associates Engineers Inc. was able to reconnect and finish giving the update regarding easements for the Woodbury Sanitary Sewer Project for the landscaping needed for the Dursina's property due to the construction of the sanitary sewer lines going through their property. Deibert added that he was working with the Liegel's who are asking that the village commit to never putting a water tower or well house on the village owned property adjacent to their property. Deibert stated that this concern comes from a 1999 study done by MSA that listed this area as a possible new well site. He added that he would continue to work on the easement and report back at a later meeting. Miller asked if there were plans for a well study. Reid said, "It's on the table within the year." No action taken.

8. **General Public Comment:** Julie Jensen- SGACC Director shared that Channel 3000's "In the 608" would be featuring four local businesses in the Spring Green area Friday, June 11, 2021 live. Jensen added that the Board had chosen Prem Meats, the Spring Green General Store, Arthur's Supper Club, and Convivio and this was a great honor for all of the Spring Green area. Damian Barta requested that the Village Board review safety concerns at Hwy 14 and Rainbow Rd intersection due to another serious accident. Reid stated she would be getting the word out to the community.

9. **Adjourn:** Motion by Broh to adjourn at 7:44 p.m. Seconded by Hauser. Voice vote. Motion carried.
