Motion by Saperstein to suspend deadlines for the purpose of determining a schedule. Seconded by Miller. Voice vote. Barta abstained. Motion carried.

Motion by Snow to approve Chapter 376 All-Terrain Vehicles (ATV) and Utility-Terrain Vehicles (UTV) with proposed amendments and suspend the three-reading rule. Seconded by Bédard. Voice vote. Motion carried.
- c. Discussion and possible action regarding proposed Spring Green Public/Private Partnerships Policy. Motion by Miller to forward the proposed Spring Green Public/Private Partnerships Policy to the Village Attorney for review. Seconded by Bédard. Voice vote. Motion carried.
