Motion by Falteisek, second by Hutnik to recommend approval to the Village Board for Certified Survey Map (CSM) submitted by BAC LLC/Steven T. Datka to combine parcels #032-0939-00000, #032-0939-10000, and #032-0937-10000 from three lots into two lots, E4919 USH 14, Town of Spring Green. - 9. Preliminary consultation with Jenifer & Dave Schauer regarding proposal for an arcade business on parcel #182-0203-00000, 127 & 157 S Wood St, Village of Spring Green. The Schauer's explained their ideas for a small arcade business in the building that is currently a laundromat. Customers would pay a flat fee which would allow unlimited play on all video game machines. No food or drink would be served inside but vending machines could be placed in front of the building along with picnic tables for customers to sit at with food and drink items. The Plan Commission discussed creating a defined use that could be added to the B-2 Zoning District. The consensus is that Prem & Lilla will draft a definition which can be reviewed and discussed at the next meeting. The Schauer's will let the Village know if they decide to move forward with the business plan. No action necessary regarding this item.
- 10. Discussion and possible action regarding modifications to the SR-1 Village Special Design Review District (Overlay). Prem reviewed the SR-1 District and the history behind the creation due to the flooding that occurred in 2008. Those in attendance discussed the different levels and the restrictions within the district. The consensus is that Prem & Lilla will draft proposed amendments for the SR-1 District which can be reviewed and discussed at future meetings. No action necessary regarding this item.
