

Minutes of Regular Session
Proceedings of the Village of Spring Green Board of Trustees
October 22, 2025 – 7:00 pm
Meeting held in-person or via Zoom & Teleconference

1. **Call to order:** Robin Reid, Village President called the board meeting to order at 7:00 pm.
2. **Roll call of Village Board members:** Members present Robin Reid, Deb Miller, Jeannie McCarville, and Damian Barta. Via Zoom & Teleconference: David Saperstein. Absent: Jean-Claude Bédard. There is currently one vacant trustee seat. Also, present: Wendy Crary, Hope Winship, Frank Glynn, Emily Whitmore, Todd Miller, Bonnie Bindl, Chief Stoddard, and Vikki Stingley. Via Zoom & Teleconference: Linda Schwanke, Adam Reno, Bob Churchill, and Kenneth 7:02 pm.
3. **Approve Minutes:** Motion by Miller to approve the minutes of the October 8, 2025 Regular Board Meeting as presented. Seconded by Barta. Voice vote. Motion carried.
4. **Review and approve agenda:** Motion by McCarville to approve the agenda as presented. Seconded by Miller. Voice vote. Motion carried.
5. **Old Business:**
 - a. Discussion and possible action regarding update on abatement of property located at 433 W. Madison Street. Glynn gave a brief update on the progress to the property located at 433 W. Madison Street. Glynn expressed concerns that he will not be able to meet the final deadline of November 18, 2025. No action taken.
 - b. Discussion and possible action regarding 2026 preliminary budget figures. Crary reviewed the updated 2026 preliminary budget figures with the Village Board. The Village Board Budget Hearing is scheduled for November 19th at 7:00 pm; with the Village Board Meeting following immediately after. Six of the seven Village Board Members are needed in attendance to vote and pass the 2026 Budget. No action taken.
6. **New Business:**
 - a. Approval of Disbursements. Motion by McCarville to approve the disbursements as presented. Seconded by Miller. Voice vote. Motion carried.
 - b. Discussion and possible action regarding appointment for vacant Village Trustee seat. Hope Winship and Todd Miller were present and given a chance to address the Village Board regarding their qualifications and interest in filling the vacant Village Trustee seat. Motion by Saperstein to appoint Hope Winship to fill the remaining term of Jennifer Snow's vacant Village Trustee seat. Seconded by McCarville. Voice vote. 5 aye and 1 nay (Miller). Motion carried. Hope Winship was asked to join the Village Board for the remaining discussions.
 - c. Discussion and possible action regarding proposed amendments for Ordinance 334 Solid Waste. The Village Board reviewed the amendments for Ordinance 334 Solid Waste. Crary stated that this would be considered the first reading and would not recommend suspending the three-read rule because of the number of changes; mostly to multi-family. No action taken.
7. **Information Items:**
 - a. Information regarding Sauk County Futures Forged – Comprehensive Plan.
8. **General Public Comment:** Bonnie Bindl expressed her concerns regarding the progress at 433 W. Madison Street and what will happen after the November deadline. Reid took a moment to welcome Hope Winship on behalf of the Village Board.
9. **Adjourn:** Motion by Barta to adjourn at 7:48 pm. Seconded by Miller. Voice vote. Motion carried.
