- 3. **Approve Minutes:** Motion by Miller to approve the official October 22, 2025 Regular Board Meeting minutes with amendment in 6.b. "reminding" should have been "remaining." Seconded by Bédard. Voice vote. Motion carried.
- 4. **Review and approve agenda:** Motion by Barta to approve the agenda as presented. Seconded by Saperstein. Voice vote. Motion carried.
- 5. Consent agenda: Motion by Miller to approve the consent agenda consisting of the following:

- c. Discussion and possible action regarding Ordinance 180 Bicycles and Play Vehicles. A brief discussion regarding Ordinance 180 Bicycles and Play Vehicles led to a decision to separate the portion regarding Golf Carts into its own chapter. Crary, will have it formatted to be reviewed at the next meeting. Saperstein will work on Ordinance 180 Bicycles and Play Vehicles over the next months. No action taken.
- e. Discussion and possible action regarding Library Board appointment. Motion by Miller to approve the recommendation of Lauren Walker to the Library Board appointment as presented. Seconded by Bédard. Voice vote. Motion Carried. Discussion and possible action regarding Village Board Standing Committee appointments. A brief discussion concluded that Barta would Chair the Sanitation and Recycling Committee and Winship would fill the vacant seats on following committees:
